Investigative Summary

Synopsis:

52 YEAR OLD WHITE MALE WITH MULTIPLE GSW. PAYSON POLICE WILL BE ATTENDING.

Description of Incident:

DR. DURHAM DID NOT HAVE ANY INFORMATION OTHER THEN THE DECEDENT'S NAME. DID NOT GET A CHANCE TO SPEAK WITH PAYSON POLICE TO GET MORE INFORMATION.

EEH53 - 12 NOVEMBER 2013 1500 HOURS: ACCORDING TO CHIEF ENGLER (928) 595-4001 OF THE PAYSON POLICE DEPARTMENT HE GAVE THE FOLLOWING INFORMATION.
ON SATURDAY, NOVEMBER 9, 2013 AT APPROXIMATELY 0730 HOURS TWO NEIGHBORS GOT INTO SOME TYPE OF VERBAL CONFRONTATION AND MR. RANDALL BURNETT SUSTAINED SEVERAL GUNSHOT WOUNDS FROM A .40 CALIBUR WEAPON. THE DECEDENT MOVED INTO THE HOME LOCATED AT TWO DAYS PRIOR TO THE INCIDENT. THE CONFRONTATION BEGAN WHEN THE DECEDENT'S DOG ESCAPED FROM HIS YARD AND RAN TOWARDS HIS NEIGHBOR'S (MICHAEL VODEN) GARDEN THROUGH A SIDE GATE. MR. VODEN CALLED 911 AND BEGAN TO DESCRIBE TO THE 911 DISPATCHER THAT THERE WAS "A DOG AND SOME PEOPLE IN MY YARD." CHIEF ENGLER STATED THAT THE DECEDENT IS HEARD STATE "WHAT ARE YOU DOING WITH THAT GUN?" AND THEN THERE ARE 4 AUDIBLE BANGS WHICH APPEAR TO BE GUNSHOTS HEARD ON THE 911 TAPE. PARAMEDICS ARRIVED AND FOUND THE DECEDENT LOCATED ON MR. VODEN'S PROPERTY NEAR HIS SIDE DOOR, AND PRONOUNCED HIM DEAD.
